1. On the 21st February 2024, the college had a meeting with members of the executive board of NSFAS.
2. The meeting constituted of the executive board of NSFAS, the college Senior Management, the SRC and representatives of the Recognised Student Formations at the college.
3. All pertinent issues affecting students which led to the illegal student unrests were tabled.
4. The NSFAS executive board members made a presentation and clarified all issues of concern as they were raised by the student leadership.
5. When the issues were clarified, the student leadership was content.
6. They were then advised to give feedback to their constituencies.
7. The institution would like to advise all students who were allocated in residences by NSFAS, to on board in the accredited residences through the private accommodation portal, and move in on their allocated residences.
8. Students who experience difficulty in registering themselves where they are allocated, should seek assistance from their respective Financial Aid Offices.
9. You are hereby advised to do so without any delays, as should these residences be full to capacity, NSFAS will not redirect you to any facility.
10. Furthermore, you will not be placed in any unaccredited residences apart from those accredited by NSFAS.
11. Additionally, living allowances and personal care will only be paid by NSFAS to students who have confirmed his/her place to stay (i.e. students qualifying for accommodation allowance)
12. A student who has not confirmed or delayed in registering in an accredited residence allocated to him/her, will not be paid personal care and living allowance until he/ she does so.
13. Finally, students are expected to attend classes effectively on 23 February 2024 to avoid further loss of tuition time.
14. It must be noted that the college will institute serious disciplinary measures to those who violate the right of others to learning.
15. Please note that the court interdict will be enforced to any transgressor who violate the order.
16. Your cooperation in complying with the directive will be highly appreciated.
