Completed documents must be placed in a sealed envelope endorsed "**SCM12/09/23**" must be deposited in the Box, Buffalo City TVET College, Admin Centre, Corner Lukin & King Street, East London, not later than **11H00 on Monday, 11 December 2023**.

A non-refundable bid deposit of R200.00 required on collection of the bid documents and must be deposited into Buffalo City TVET College, **STANDARD BANK, Account Number: 042042445. Ref No: 2022TEND13E**. Proof of payment must be hand delivered on collection of the tender documents. Tender documents will not be emailed to service providers.

#### **Bidders shall take note of the following bid conditions:**

Late bids will not be accepted. Failure to complete all supplementary information may result in the bid being deemed null and void (eliminated). Preferential Procurement Policy Framework Act (PPPFA) Regulation 2022 principles will apply. **Bidders must be registered with PSIRA and be in good standing.**

#### **Price and BBBEE**

Please note: A sworn affidavit in terms of the amended B-BBEE codes will also be accepted for deemed exempted micro enterprises (EME) and Qualifying small enterprise (QSE). 100 Total Points.**

**Submission of tenders will be deemed to indicate that the tenderer has accepted the tender adjudication procedures and principles as contained in the bid documents.**

All agreements awarded as a result of this process will be covered by the General Conditions of Contract ([www.treasury.gov.za](http://www.treasury.gov.za)).

**Please note: Compulsory Briefing Session will be held at the Buffalo City TVET College, Admin Centre Boardroom on Wednesday, 15 November 2023 @ 11h00.** It is the responsibility of the service provider to ensure that the briefing register is signed. Bid forms that are incomplete or incorrect will result in the disqualification of that application. Suppliers are requested to be registered for VAT and must submit a copy of SARS Tax Clearance Certificate with a pin in their application.

Telegraphic, email, telexed or faxed bids will not be considered. The college reserves the right to cancel the bid or not to accept the lowest bid offered and also not to award in terms of this process.

No verbal or telephonic queries will be attended to. Any attempt to verbally contact with the Buffalo City College's employee to influence outcome of this tender will lead to disqualification of the bid.
